Behavioral Expectations Participant/Family Agreement

Instructions to Participant and/or Parent/Guardian:

Please thoroughly read the [Summer Chill Event Guidelines](#) and the below [Participant/Family Agreement](#) and take the time to consider your willingness to abide by our DYNA policies. Attendance at a DYNA event requires that both the participant and parent/legal guardian to sign this form. Please sign and date in each required field and return the signed portion to the DYNA office prior to the deadline. Maintain your copy of the agreement in your possession to review prior to the event.

Participant/Family Agreement

The DYNA Summer Chill is a private event open to current (medically managed) DYNA members and their families. The purpose of the event is to provide the opportunity for our youth members to achieve fellowship and receive current medical information. Additionally, medical professionals often attend, observe, and participate in this event. DYNA, Inc. strives to create an environment of comfort, respect and camaraderie. Our members and their families should demonstrate responsible behavior and should represent themselves and the DYNA community in a positive and respectful manner at all times. DYNA has members ranging in age from pre-school to adulthood in attendance. We provide an agenda focused on our DYNA youth members and promote a wholesome atmosphere for all to enjoy.

Please know that behavior at DYNA events must be family-friendly, G-rated, and respectful to all in attendance as well as to event planners, medical professionals, and facility employees. The Summer Chill is a drug-free (except for prescribed medications), smoke free, alcohol-free zone for our youth members. Boisterous, disruptive or promiscuous behavior is not allowed at any time, be it in public spaces or private rooms - during formal sessions or casual free time.

The focus of the Summer Chill is for DYNA Youth Members to have the opportunity to participate in a positive, renewing set of activities in a comfortable, relaxing and productive environment. While DYNA provides the opportunities, please accept that parents must remain responsible for their children's behavior while in attendance. Parents are to remain fully aware of the child's location, the activities in which they are participating and the people with whom they are interacting. Neither DYNA event planners nor its volunteers will baby-sit or be held responsible for your child/children.

Inappropriate behavior by any member of your participating party will be reviewed by DYNA representatives. Upon such review a decision will be made and action will be enforced immediately and such decisions are non-negotiable. Behavior determined to be inappropriate and/or disrespectful to the group's well being will result in the immediate and complete expulsion of the member and his/her attending party from the activities and the facility. No refunds will be granted. Expulsion from the event will likely initiate membership revocation.

If a youth member, family member, or parent has tendencies toward disruptive, violent, or unruly behavior, or has a mental health disorder, this is not the event for you.

All event attendees must reside at the hotel in order to attend this event.

This event is not for those still in extreme stages of illness or those with severe disability due to illness. Members who are still quite symptomatic (experiencing frequent fainting, regular seizures, sensory regulation issues, require wheelchairs or other mobility devices, receive daily intravenous Therapy/Parenteral Nutrition, and are unable to self evacuate a high rise hotel via stairs) must wait until their condition is under better control to attend this event. The Summer Chill is held yearly in order to allow very symptomatic members an


opportunity to become better medically managed prior to attending. Due to the nature of their conditions, it is in such individual's best interest to remain at home or in the hospital.

The DYNA Summer Chill event is not an activity provided for dating or romantic teenage relationships and promiscuous behavior among our youth members is strictly prohibited.

Note: If you find yourself unwillingly in the presence of any inappropriate behavior - remove yourself from the situation or risk the consequences of involvement.
